71 The Census of Agriculture indicates that cropland used for pasture or grazing decreased 64%, from 131,686 acres in 1997 to 46,686 acres in 2007. During this same period, the amount of land described as permanent pasture or rangeland increased from 86,835 acres in 1997 to 137,165 acres in 2007. The Census of Agriculture defines permanent pasture or rangeland as grazable land (e.g., meadow, prairie, or range consisting of various types of grasses) of variable quality. However, the decrease in cropland acreage devoted to pasture or grazing and the increase in permanent pasture appears to reflect a question order change in the Census of Agriculture. For example, in the 2002 (and earlier years) Census report forms the Cropland Pasture question was included in item 1a. In 2007, it was moved to item 2c. The Permanent Pasture question was included in item 3 in 2002 (and earlier years), but in 2007 it was moved to item 2a, above Cropland Pasture. Consequently, it is unclear how to read this trend.
