The Vermont Sustainable Jobs Fund, a 501c3 nonprofit organization, provides business assistance, value chain facilitation, network development, and strategic planning in Vermont's agriculture and food system, forest products, waste management, renewable energy, and environmental technology sectors.

We serve the needs and interests of Vermont businesses, organizations, and government partners who are working hard to strengthen our local and regional food system, rebuild the forest products industry, meet Vermont's renewable energy goal, and invent clean technologies that benefit society. Our creative and adaptive approach to positive, systems-level change elevates the well-being of Vermonters, our communities, and the environment in the face of climate change, now and for future generations.

The Vermont Sustainable Jobs Fund takes a <u>network development</u> <u>approach</u> to improving economic development in the sectors we serve. We understand no one organization/business/government agency can fully address the economic, social, and environmental challenges within these sectors. Therefore, we rely on collaborative relationships with our <u>partners</u>, mission alignment with our <u>funders</u>, and the success in creating sustainable jobs by our <u>clients</u>.

We identify gaps and bottlenecks in <u>business assistance</u>, <u>access to capital</u>, and <u>sector-specific value chains</u> so Vermont businesses can take advantage of new market opportunities that create jobs, while also benefiting Vermont communities and the environment.

Business Assistance Services

We provide tailored, high-touch planning, coaching, and advising for business owners and their management teams to advance profitability, job creation, and sustainable business development.

Our team of experienced business coaches work intensively with clients in structured sessions over 12-18 months to provide support, advice, and leadership training in order to recognize ways in which they can improve the effectiveness of their business. Additionally, we help our clients explore and prepare for the right match of growth capital (e.g., debt, equity, royalty financing) for their scale and stage of business.

▶ IMPACT: VSJF's year-long intensive coaching engagements with 22 farm and food-related businesses between 2011–2017, resulted in more than \$14 million in new capital raised, more than \$2.5 million increase in payroll and at least 43 new full-time and 49 part-time jobs.

WHAT IS SUSTAINABILITY?

Sustainability, by definition, is at the intersection of economic, social and environment interests. VSJF takes the same approach to market development opportunities — we look to the intersection of sectors to conduct market research, manage demonstration projects, and bring promising initiatives to scale.



Agriculture and Food Systems

Expanding jobs and overall economic activity in Vermont's farm and food sector, for the benefit of all Vermonters.

The Vermont Sustainable Jobs Fund serves as the administrator of the Farm to Plate Network and executes the analysis and goal tracking of the Farm to Plate Strategic Plan implementation. The Network is comprised of farms, food production businesses, specialty food producers, educational institutions, nonprofit organizations, funders, capital providers, and government personnel. Through the Network we create the space for strategic industry-level conversations and high-impact projects that are reshaping our local food system.

Vermont's food system generates more than \$10 billion in economic output and supports more than 64,000 jobs and 12,000 businesses. While dairy and its by-products remain the largest agricultural product with 65% of all farm-gate sales and annual sales of more than \$1.3 billion, sales of locally raised meat, vegetables, craft beer and spirits, and other value added products have grown significantly in recent years.

▶ IMPACT: Since Farm to Plate began, Vermont's food system employers have added 6,374 net new jobs (2009 to 2016), an 11% increase, and 800 net new farms and food businesses have been created. Food and beverage manufacturing employment increased 32% (2,156 jobs) from 2009 to 2016 and now total 6,784 jobs, while also becoming the second largest manufacturing sub-sector in the state with over \$982 million in annual sales (2013).





Climate Economy

Confronting climate change through innovative economic development initiatives that will build a national reputation, create jobs, and attract youth and entrepreneurism to Vermont.

Through the <u>Vermont Climate Economy Business Network</u>, we are building a sense of community, creating opportunities to explore business-to-business collaboration, and providing targeted expertise to develop and grow Vermont businesses whose products and services prepare for, mitigate against, or adapt to the impacts of climate change.

Accel-VT is a business accelerator providing startup support, business planning, mentorship, and access to capital for climate economy businesses who are interested in establishing a business in Vermont. A competitively selected cohort of eight seed stage ventures are developing innovative products aimed at solving the challenges related to the monitoring and control of distributed energy (e.g., storage, electric vehicles, solar, community scale wind, combined heat and power) to improve their value while providing safe, reliable, and affordable electric service to all customers.

VSJF also works collaboratively with the Vermont Council on Rural Development's Climate Economy Initiative and <u>Climate Economy</u> <u>Action Team</u> on an even broader climate economy agenda.

Note: Three, four-day onsite "sprints" are happening in Vermont from December 2017 to February 2018. Our partners include Burlington Electric Department and the Center for Emerging Technologies. Twenty-two corporate and philanthropic sponsors, as well as VLITE, are financially supporting this program.

Forest Products

Catalyzing new products and innovative approaches to rebuild Vermont's forest products economy.

Our Forest Products Program is helping to support and promote the industry by developing value chain investment strategies to improve market opportunities for individual firms and the industry as a whole. The program is a collaborative partnership between the Vermont Sustainable Jobs Fund, the Vermont Working Lands Enterprise Initiative, and the Northern Forest Center.

The Vermont Forest Industry Network tackles initiatives that no single business or organization could tackle alone. 

IMPACT






