We’ve supported hundreds of businesses, built powerful networks, and shaped policies that put wellbeing at the center of economic development. 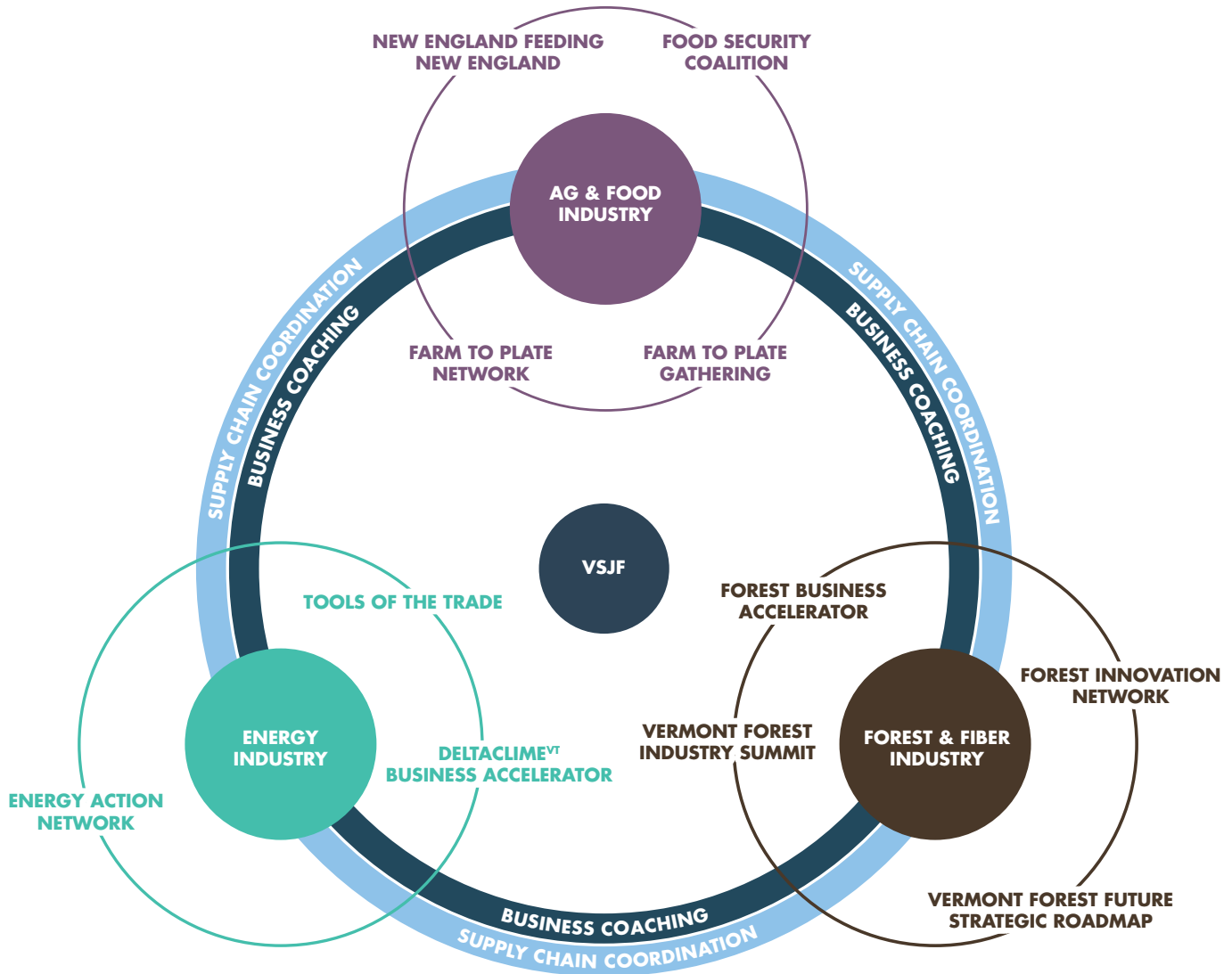

# What is VSJF?



VSJF is an independent 501(c)(3) nonprofit created by the Vermont Legislature in 1995. We partner with state government, businesses, and nonprofits to build a resilient, equitable, and climate-conscious economy that serves all Vermonters.

Our mission is to nurture the economic prosperity, ecological health, and social connectivity of people, businesses, organizations and communities in Vermont for the benefit and well-being of everyone who calls this state home.





## What We Do & How We Do It

We provide business assistance, supply chain coordination, network development, and strategic planning across five key sectors:

- Agriculture and Food Systems
- Forest and Fiber Products
- Renewable Energy
- Environmental Technology
- Waste Management

Through cross-sector collaboration and systems-level thinking, our partnerships position Vermont as a state where social impact entrepreneurs want to start and grow businesses. We strengthen connectivity, alignment, and coordinated action across our networks to foster an economy that benefits both people and the planet.

### What's in a Name?

Jobs or the environment? The early 1990s were characterized by a debate pitting environmental protection against economic development. Many did not believe both could exist simultaneously.

Sustainable economic development was a new idea at the time and it provided a group of socially responsible business leaders with a theme, a vision, and goals to work toward: Vermont could meet the economic needs of its citizens without compromising future generations or the planet by creating sustainable jobs that pay livable wages, support well-being, and contribute positively to society and the environment.

With advocacy led by Vermont Businesses for Social Responsibility and bipartisan support from the Vermont Legislature, the Vermont Sustainable Jobs Fund was created in 1995. Our name reflects our dual commitment to accelerating sustainable businesses and investing in Vermont's future.

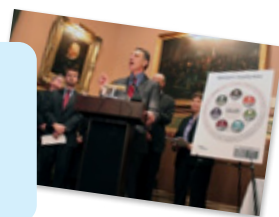

# Helping Vermont's Entrepreneurs Build Stronger Small Businesses

In Vermont, small businesses aren't just common, they're essential. With 93% of businesses employing fewer than 20 people, they power our local economy, make-up 31% of all jobs, and reinvest their profits right back into our communities. Many of these businesses are rooted in food and agriculture, forest products, climate tech, and waste management—sectors where VSJF is focused.

Our [business coaching services](#) are designed to meet entrepreneurs where they are and help them develop the skills to work “on their business.” We pair value-added businesses with seasoned, C-suite-level coaches who bring decades of experience and a fresh perspective. Together, they build actionable growth plans that strengthen operations, boost sales, and position businesses for long-term success.

## Our Impact

In 2025 alone, we worked with 29 businesses, and over 95+ since 2005, to help them scale sustainably. Our coaches go beyond the numbers. They help entrepreneurs sharpen their leadership, streamline operations, forecast revenue, build strong teams, and access new capital. The result? A holistic roadmap for both the business and the entrepreneur behind it.

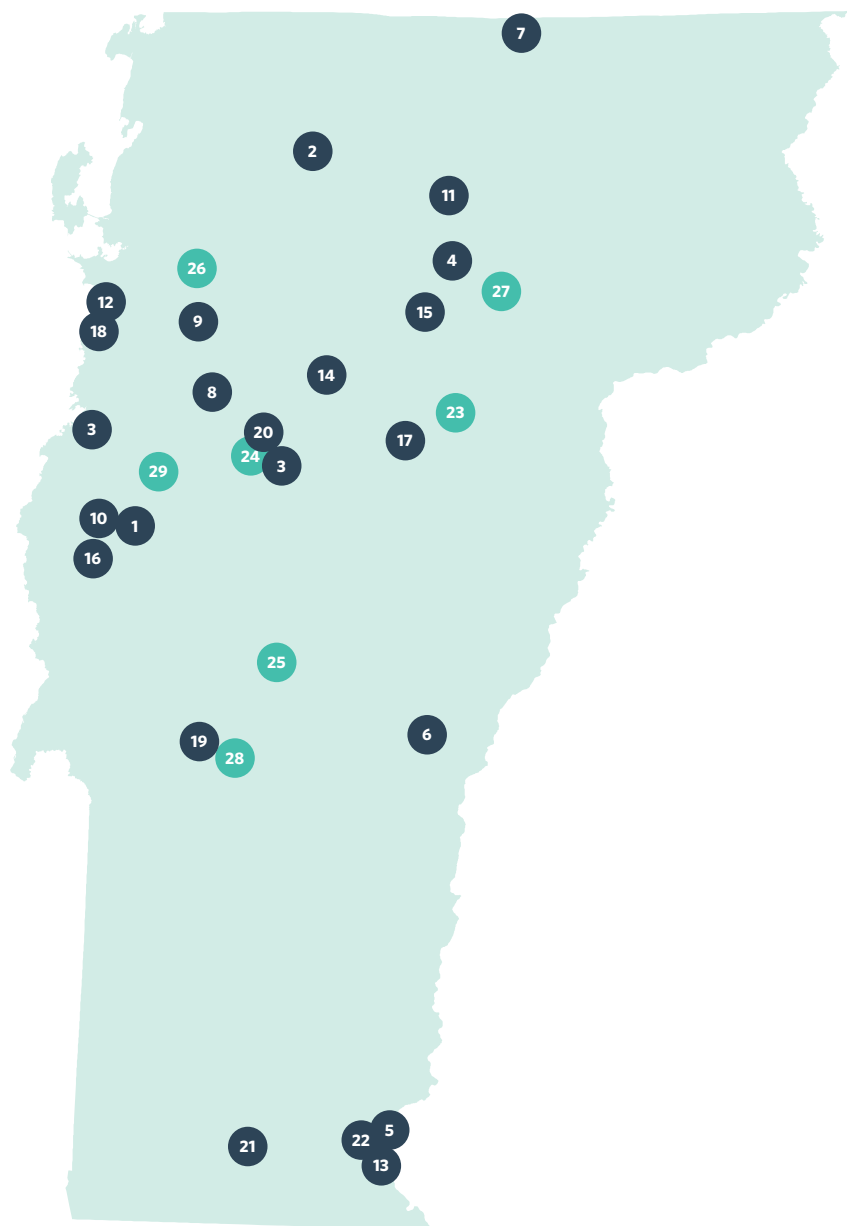

# Investing in Vermont's Clean Tech Future

Vermont has a clean energy vision for its future, and our [DeltaClime<sup>VT</sup> business accelerator program](#) is helping to make it a reality. Considering that utility companies are required to use only clean energy by 2035, there's no time to wait—we need to invest in our clean energy future now.

Each year, we bring a cohort of 7-9 start-up companies with innovative climate and energy solutions to Vermont to participate in our rigorous business accelerator. With best-in-class Lens of the Market curriculum delivered by ecosVC, we work closely with experienced mentors from Vermont utilities, energy companies, and business professionals. The cohort focuses on fine tuning their product or service and learns how to grow their clean tech business. One company is chosen by their peers to win \$25,000 and various utilities select companies for pilot projects to further test their products and services.

With funds from the Small Business Administration secured by U.S. Senator Peter Welch, we are deepening our investment in Vermont's clean energy future by initiating four larger-scale pilot projects between DeltaClime<sup>VT</sup> alumni companies and Vermont utilities. These low-risk, real-world pilots will allow alumni companies to validate performance while their utility partners gain relevant data—paving the way for broader adoption.

We are proud to announce the following pilot projects have been awarded and we are looking forward to reporting on their results over the next two years:

### **Bidirectional Energy and Vermont Electric Coop:**

Will install 3 bidirectional EV charging systems in VEC member homes, deploying a V2G software platform for monitoring and control, establishing a demand response program framework scalable across Vermont utilities, creating an economic incentive structure that demonstrates participant value.

### **Noteworthy AI and Vermont Public Power Supply Authority:**

In collaboration with Northfield Electric and Burlington Electric Departments, Noteworthy will use innovative smart cameras and AI on existing fleet vehicles to passively collect and analyze critical infrastructure data, such as vegetation encroachment.

### **EVmatch and Burlington Electric Department:**

Will expand on their previously successful work together to increase access to EV charging for up to 16 new charging ports at up to 8 rental/condo/multi-family building sites in Burlington.

### **Revvit and Green Mountain Power:**

Will result in the installation of electrical infrastructure and Revvit's Level 1 EVSE at 1-5 home owner associations or condo communities throughout GMP's service territory. This will ease the range anxiety that can prevent individuals living in multi-unit housing from switching to an EV.

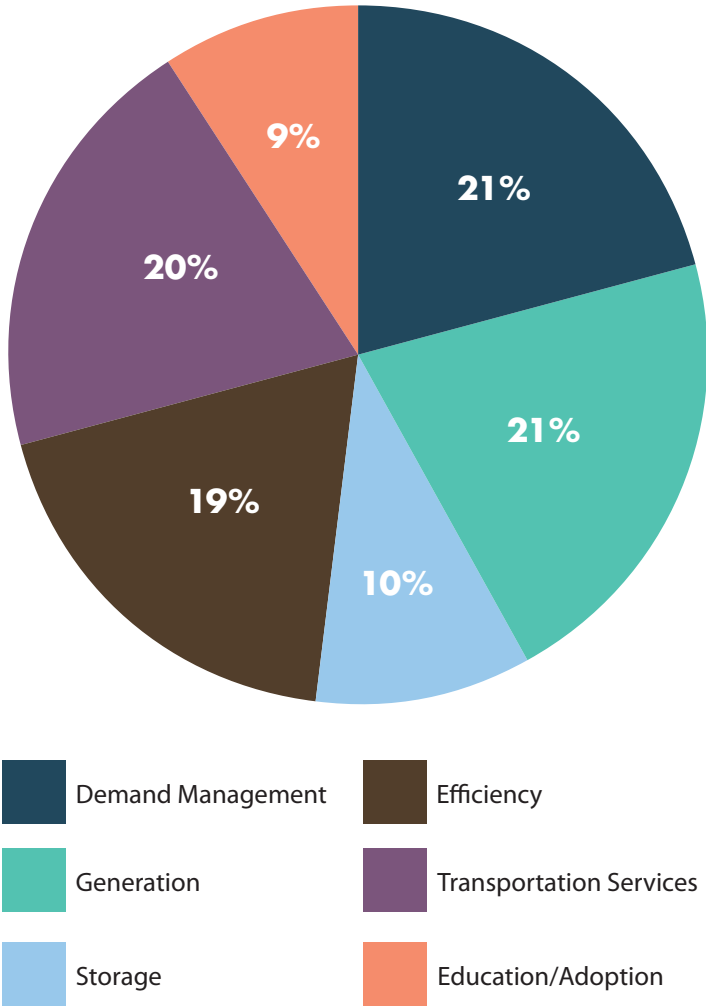

# Innovation in the Forest Economy

The forest and fiber products industry could soon be at the forefront of innovation, resilience, and the circular economy. New, innovative products, such as utilizing wood fiber for prepared foods packaging or wool fiber for insulation, present myriad opportunities rooted in natural resources that cultivate a resilient, thriving regional economy.

We are evolving our program to focus on innovators in our rural communities who are developing or expanding markets for natural wood, wool, hemp and other plant and animal-based fibers easily grown or raised in Vermont's rugged landscape. VSJF is supporting this industry through network development, supply chain coordination, and strategic communications.

Just as the northern forest is regional, so is our impact. Our annual [Vermont Forest Industry Summit](#) has evolved to include more regional partners who strengthen our forest economy. And our work with the Vermont Department of Forests, Parks and Recreation, UNH Extension, Vermont Green Building Network, Smokey House Center and others is aimed at bringing together supply and demand partners who can address bottlenecks in the supply chain, and expand the use of locally-sourced wood in mass timber construction, packaging, energy production and other valuable products.

## Introducing the Forest Business Accelerator

In 2025, VSJF re-launched the [Forest Business Accelerator](#), in collaboration with Vermont State University and ecosVC, to provide forest business startups and seed stage businesses with a comprehensive commercialization curriculum and connections to industry experts, customers, suppliers, partners, and investors.

This four-month intensive program provides forest-based business startups with the tools they need to build and validate their business case, business model and go-to-market strategy. It is tailored to the needs of 'hard tech' advanced wood manufacturing and precision forest technology companies. The program culminated with a \$15,000 award to peer-selected [Bullfinch Earth](#).

Wool fiber has the potential to disrupt the use of oil-based materials in clothing, construction, and soil amendments. We explored this potential by partnering with a graduate of the University of Vermont’s Sustainable Innovation MBA program to assess the quantity and quality of Vermont-grown wool and its potential markets. In 2026 we will share the data with stakeholders who are interested in growing a local and regional wool fiber value chain.

# 15 Years of Strengthening the Farm and Food Sector

For 15 years, the 300+ organizations that make up the Farm to Plate Network have been working to make Vermont's food system more prosperous, environmentally sustainable and resilient, and socially just. VSJF provides “backbone” support to the Network, enabling strategic coordination, collaboration, and action. Our work supports Vermont's needs today and for future generations

### Increase sustainable economic development and create jobs in Vermont's food and farm sector

Farm to Plate's economic development strategies focus on strengthening the capacity and viability of Vermont's food production, processing, storage, and distribution while increasing local food sales across direct, restaurant, institutional, and retail market channels.

- 7 farms received technical assistance as part of the Beef on Dairy Project.
- 120 people participated in retail trainings and received technical assistance through our Independent Grocers Project.
- 8 food businesses and nonprofit food hubs received infrastructure planning and implementation technical assistance for projects representing \$3.16 million in investment.

- Farm to Plate relaunched the Vermont Food Hub Collaborative and convened the 6 major food hubs to work on improving coordination of their distribution services to small farms and food producers.

### Improve soils, water, and resiliency of the working landscape in the face of climate change

Farm to Plate's environmental sustainability strategies focus on climate policy, land access funding and financing, land use regulation, and supporting and incentivizing innovative farming practices that keep agricultural land in production while nurturing the ecological health of Vermont's working landscape.

- Advocated for F2P's priority strategies to be incorporated into the [2025 Vermont Climate Action Plan](#). Of the Priority Recommendations adopted by the Climate Council's Agriculture and Ecosystems Subcommittee, 64% came from the [F2P Strategic Plan](#).
- Identified two critical priority strategies from the Strategic Plan and the [Vermont Food Security Roadmap](#) as high urgency recommendations for [Vermont's Resilience Implementation Strategy](#)—a joint effort of Governor Phil Scott and Treasurer Mike Pieciak.
- Examined five local projects with alternative land ownership components, such as shared equity arrangements, which have potential enduring benefits to communities, farmers, and expanded racial and gender equity.

## Improve access to healthy local foods for all Vermonters

Farm to Plate's local food access strategies focus on cultivating cross-sector partnerships, advancing statewide food security policy, and ensuring local food is readily available in all places where food is sold, served, or provided. We are a founding member of the [Vermont Food Security Coalition](#), a collaboration between seven organizations working toward making Vermont food secure by 2035.

- VSJF collaborated on the Coalition's 2024 legislative policy priorities, which resulted in:
  - \$450,000 in one-time funding for NOFA-VT's Crop Cash and Farm Share programs.
  - \$1.5 million for Vermont Foodbank, including \$500,000 for the Vermonters Feeding Vermonters program.
  - \$1.6 million in base funding for the Land Access and Opportunity Board to address housing equity and land access for historically marginalized or disadvantaged communities.
- The Vermont Food Security Coalition launched its website, a significant step forward in reaching more supporters and raising their profile.

# Increasing Local Food Consumption in New England to 30% by 2030

VSJF proudly serves as the backbone organization for New England Feeding New England (NEFNE), a 10-year initiative led by the [New England Food System Planners Partnership](#) (NEFSPP). Our shared goal: 30% of the food consumed in New England is regionally produced by 2030.

## Building a Resilient Regional Food System Together

NEFSPP is a collaboration between seven state-level food system organizations and representatives from the six-state agricultural, economic and environmental departments in New England. NEFNE is the Partnership's primary initiative and is driving coordinated action across the region to shift food sourcing closer to home.

To measure our progress towards the 30% x 2030 goal, NEFNE conducts [Local Food Counts](#) across all six states—using the same methodology we've used in Vermont to measure our success in growing local food sales from 5% in 2011 to 10% in 2020. The 2025 count is underway with results expected in late 2026. Thanks to newly available NielsenIQ data, we are updating our 2022 Local Food Count with deeper insights into regional purchasing at supercenters, grocery chains, and convenience stores. This will give us a clearer picture of where we're gaining ground and where we need to push harder.

## Beyond the Count—Catalyzing Regional Action

The Partnership is also advancing key strategies to strengthen the regional food system, including:

- **Supply Chain Investment and Coordination:** Through the USDA's Regional Food Systems Infrastructure Program, we're helping build a more connected, efficient food system.
- **Land Production and Crop Analysis:** Understanding what we can grow more of in the region and where it is essential to scaling regional food distribution.
- **Capital Alignment:** We're bringing together funders, lenders, and investors to strategically organize around the capital needs of food system businesses across New England.
- **Retail Grocers:** In 2026, modeled after the successful Vermont Retail Grocers Project, initiatives will begin to assist independently owned retail grocers across the region to source and merchandize more regional food products.

In November 2025, the Vermont Prosperity Project officially became the Wellbeing Economy Alliance of Vermont (WEAV). This name better reflects our shared vision for an economy rooted in care, equity, and resilience. The decision followed a thoughtful dialogue among the member organizations, sparked by a desire to clarify our identity and communicate our purpose more powerfully to others across Vermont and beyond.

The name “WEAV” emerged as the clear favorite, chosen for its clarity and alignment with our mission: to weave together people, organizations, and systems in service of a thriving Vermont—where wellbeing is the measure of success.

## Looking Ahead: WEAV in 2026

In 2026, WEAV will deepen statewide collaboration by connecting networks, organizations, and communities advancing wellbeing-centered economic practices. We will share stories to spotlight innovative initiatives that demonstrate equitable, resilient pathways to a thriving, equitable, and resilient Vermont. Through storytelling, policy engagement, and leadership development, WEAV will amplify impact and foster systemic change across sectors.

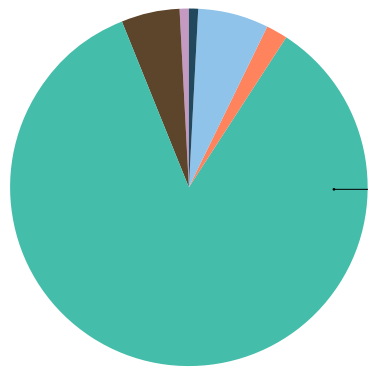

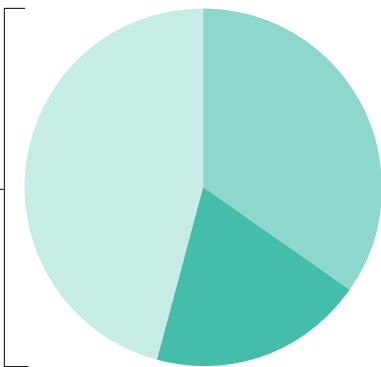

VSJF Revenue by Source



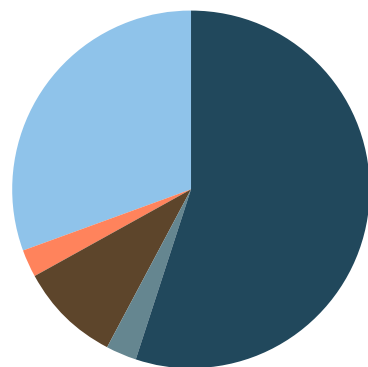

Grant Revenue by Source<sub>2</sub>



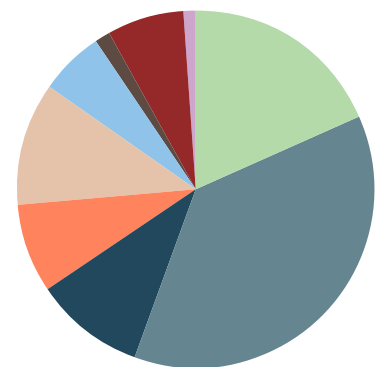
